

Home Share Application

Vashon HouseHold is the only nonprofit on Vashon that is focused on affordable housing. Home Share is a unique and nontraditional housing program that brings together people who have housing to offer with people who are looking for housing.

Home Share is a process that starts when you submit an application. All Home Share participants are screened and references are checked. Home Share staff will reach out to set up a meeting to get to know you, your situation, and your needs more clearly so that we can "match" you with the best situation possible. Once you are matched we ask everyone to meet at our office to get to know each other and see if they want to continue with the process of setting up living arrangements. If that is the case, we all make a visit to the home that is being offered and discuss the living situation and the possibility of work exchanges, if applicable. Then we all meet again at the office to finalize the agreements in writing. We have an extensive Home Share Agreement that was based off a document developed at Stanford University for home share programs.

We provide ongoing support to all parties and follow up within a month to make sure the agreements are clear and do not need amending or changing. We also have trained staff to help navigate conflicts, should they arise.

SAFETY, CRIMINAL HISTORY AND BACKGROUND CHECK POLICY

Vashon HouseHold and Home Share hold the right to disqualify anyone from the program that may hinder the health and/or safety of themselves or others. It is the policy of Vashon Household's Home Share Program to screen all applicants for criminal convictions. Washington residents are screened through the Washington State Patrol. If an applicant has lived outside of Washington in the last ten (10) years, a multi-state background check will be used. An adverse background check finding does not automatically disqualify you from entering the Home Share Program unless it is recent and of the offenses that are listed in WAC 388-113-0020 which would bring health and safety into question.
